



## Prepaid holiday promotion

The Maloja Palace is pleased to offer its customers the following promotion:

1. By subscribing to the newsletter and consenting to the use of your personal data for commercial purposes, you will receive the 'De Renesse' discount – consisting of 10% off the prices listed on Booking.com. The request must be made at the time of booking;
2. For our most loyal customers, we have created the 'De Renesse' package, which includes the following:
  - prepayment of CHF 25,000 including VAT
  - duration of 5 years from the date of payment under the following conditions:

For a number of overnight stays per year less than or equal to 30 made by the customer and/or persons nominated by them, the value attributed to each overnight stay will be equal to the price published by Booking.com for the 'Junior Apartment' type in the residence formula, i.e. with cleaning and linen change once every 7 days, (regardless of whether another category of room or apartment is actually used) with the 'De Renesse' discount described in point 1 (defined below as the 'Junior Price').

For overnight stays by the above-mentioned persons, if they exceed a total of **30 nights** in the same period, the price for each overnight stay will be **CHF 120** including VAT in the residence formula.

The price of **CHF 120** including VAT does not apply during periods of high occupancy (i.e. from 27 December to 5 January of the following year and during all weekends (from Friday to Sunday as the departure day) from the fourth weekend in January to the second weekend in March, including the Engadiner Skimarathon). During these periods, the 'Junior Price' as defined above will apply. However, these overnight stays will be counted into the above-mentioned threshold of 30 nights per calendar year.

If the use of the rooms or suites exceeds the amount corresponding to the aforementioned flat rate, the customer undertakes to pay Maloja Palace AG additional

payments calculated according to the same conditions as above, up to a maximum of CHF 5,000 in addition to the CHF 25,000.

For higher amounts, the customer must purchase another package.

If the overnight stays are not used during the 5-year period and, therefore, if the package is not used in full, the customer cannot request a refund.

Therefore, the price is to be considered paid with the 'empty for full' formula.

In addition to the price per night, the package can also be used to pay the tourist tax. Please note that, for the purposes of calculating the 30 nights in the calendar year, all overnight stays made by the customer personally or by persons nominated by them are considered together. Therefore, the limit of 30 nights is to be understood as a total and does not refer to each individual separately.

The package allows you to book rooms or suites up to 30 days before the end of the chosen stay.
